### Recommendation:

- 1) Approve the following grants totaling \$566,696 for the Emergency Solutions Grant Program:

  - Catholic Charities Housing First - \$71,724
  - MN Council of Churches - \$97,630
  - St Stephen's Human Services - \$203,334

## Supporting Information

The federal Emergency Solutions Grant (ESG) program is a federally funded program that was established by HUD to address specific housing stability service needs of persons who are homeless or are threatened with homelessness. The funds that are being issued can be used for services similar to those under the Federal Homeless Prevention and Rapid Re-Housing Program, which ended in May of this year. Those services include Homelessness Prevention and Rapid Re-Housing: both components fund housing relocation and stabilization services (including rental application fees, security deposits, utility deposits or payments, last month's rent and housing search and placement activities). Funds may also be used for short- or medium-term rental assistance for those who are at-risk of becoming homeless or transitioning to stable housing.

A request for proposal was issued on July 7, 2012 to service providers within Minneapolis. A total of ten proposals were received which were reviewed by a committee comprised of the following members:

The following proposals are recommended for funding:

**Ascension Place/St Anne's - \$177,400** - To enhance Ascension Place's Young Family Aftercare Program, which provides intensive case management and support for young families, who have been homeless. Funds will provide for case management, housing application fees, damage deposits, and rental subsidies.

**Catholic Charities Hope Street - \$76,608** - For expansion of re-housing services for youth attending Minneapolis high schools. Program will provide housing search/placement, family mediation, medium term rental assistance/security deposits, moving assistance, case management, and independent living skills training.

**Catholic Charities Housing First - \$71,724** - For housing and stabilizing homeless adults without children through rapid re-housing program consisting of housing search and placement and assistance support.

**MN Council of Churches - \$97,630** - For the Refugee Supportive Housing Network to provide prevention and rapid rehousing for refugee families through shallow rent subsidies and housing stabilization services.

**St Stephen's Human Services - \$203,334** - For provision of intensive case management services and rental assistance for high barrier homeless families. Services will include a complete assessment of needs, barriers and strengths, intensive in-person case management, counseling, advocacy and connections to appropriate social services to create a stable housing plan with appropriate self-sufficiency supports.
