**188.185. Qualifications of applicant. No food or grocery license shall be issued to any applicant who does not meet the following qualifications:**

(b) Within five (5) years of the date of the application, the applicant cannot have been convicted of any crime related to the occupation for which the license is sought, which conviction has not been, pursuant to law, annulled or expunged, including but not limited to the willful violation of any law dealing with food subsidy programs or the sale, possession, manufacture or transportation of controlled substances. The provisions of Minnesota Statutes, Chapter 364 shall govern the enforcement and application of this subsection including the right of an applicant to show competent evidence of sufficient rehabilitation and present fitness.

1. Mr. Bradley Kohler was convicted of a financial crime in January 2014 as a result of a crime in 2011. He was sentenced to five year's probation and restitution. Mr. Kohler's probation officer reported he is in compliance with his probation and may be discharged from probation in January 2016. Mr. Kohler agrees to submit a report from his probation officer, to indicate he is in compliance with the terms of his probation, with his license renewal each year until his probation. The City of Minneapolis reserves the right to

The City of Minneapolis reserves the right to a denial or revocation of the business license should the terms of his probation be violated.

I have read the conditions listed above. I agree with the conditions and understand that failure on our part or on the part of my company or employees to adhere to these conditions, may be cause for future adverse license action, including the suspension, revocation, or denial of the renewal of the L149 51097 REJUVAMIX CAFE license. These conditions will be effective for the duration the license operates at these premises, unless otherwise amended by the City Council of Minneapolis.
