Samuel Harriman will be the owner and manager of Sisyphus Brewing. He has work experience in an off sale liquor establish and a fast food restaurant.

Police Review

Minneapolis Police Licenses and 5th Precinct have reviewed the financial, criminal and security plan for Sisyphus Brewing LLC and Samuel Harriman. They concur this applicant meets the minimum ordinance requirements

Premises

The business will be 6845 square feet. The taproom will be 1477 square feet. Seating will be at 10 tables with seating for 46 chairs. The bar will have seating for 13. Additional seating will be on benches for a total of 70 seats. There will be no outdoor seating. There will be two shuffleboard tables in the tap room area. Drink ledges surround the exterior walls in the taproom. The occupancy load is 99.

Business Plan/Operations

Sisyphus Brewing will be a nano- brewery. They will only brew beer for consumption on the premises. At this point, they are not seeking a growler license for off sale consumption. They are applying for a taproom license only. They plan on having Class D entertainment to include one comedian and podcast events. There hours of operation will be; Tuesday to Thursday: 3:00 p.m. to 10:00 p.m. and Friday to Sunday: 12:00 p.m. to 1:00 a.m. There will not be an outdoor area. They do not plan to have food service in the micro-brewery but do plan to invite food trucks to serve in their rear parking area.

Sisyphus Brewing, LLC has applied for a state micro-brewery license which is required to obtain a taproom license in Minneapolis.

Public Hearing

A public hearing will be held at CDRS on Tuesday, June 3, 2014. Notices were sent to property owners and residents within 600 feet of the applicant's front door to the business.
