Police Review

Minneapolis Police Licenses and 5th Precinct reviewed the financial, criminal and security plans for Red Wagon Pizza Company. They have determined that Red Wagon Pizza Company meets the minimum ordinance requirements for an alcohol license.

Premises

The premises are located on Penn Ave S between W 54th St and W 55th St. They will occupy the first floor. There will be interior seating for 44 patrons. Eight seats will be located at a food service bar. The rest of the seating will be at tables and chairs. The main entrance, for the restaurant, is located on Penn Ave S, just south of W 54th St. This same entrance will accommodate the outdoor patio. The patio will have tables and seating for 20. There will be no outside speakers. It will be located on the Penn Avenue side of the building and sit in the same footprint as the previous business' outdoor patio. There will be no amusement devices. The applicant will not offer any mechanical amusement devices or charitable gambling on the premises. They are not sponsoring any sports teams.

Business Plan/Operations

Red Wagon Pizza Company. is a full service restaurant that focuses on wood-fired pizza fare that will be open Monday – Friday 11-am-1pm Saturday-Sunday 9am-1am on the interior, Monday – Thursday 11:00am-10:00pm, Friday 11:00am-11:00pm, Saturday 9:00am-11:00pm, and Sunday 9:00am-10:00pm on the exterior. Red Wagon will have a Class E license which permits no live entertainment or DJs. There will be no entertainment or outdoor speakers on the patio. Red Wagon Pizza Company uses the ALE Training program for alcohol servers and management upon hire and as needed.
