The manager is Kristina Lawson. Ms. Lawson is the current manager of the Black Sheep Pizza in St Paul, MN. She has no criminal history.

### **Police Review**

Minneapolis Police Licenses has reviewed the financial and criminal histories of the applicants and have determined that the minimum ordinance requirements have been met. Minneapolis Police Inspector Todd Loining met with the owners of Black Sheep to review their security plan. He is satisfied that the plan presented adequately meets their level of entertainment.

### **Premises**

**Indoor: The restaurant will consist of 4215 square feet. They will have seating in the amount of 124 seats at tables and chairs throughout the restaurant. There will be no bar area. All seating will have food service.**

### **Business Plan/Operations**

Black Sheep Pizza is a full service pizza restaurant. There will only be background music inside the restaurant. No exterior speakers. Sound muffling equipment is placed throughout the restaurant to prevent exterior sound.
