1. During the period of time a class is in session, no other business can use the same space as the cooking school.
2. The alcohol must be stored in a manner as to not allow anyone other than an employee of the Kitchen in the Market to have access to the alcoholic beverage.
3. Alcohol cannot be removed from the Kitchen in the Market area known as Suite 107. The license will not be allowed to apply for any temporary on-sale license that allows the sale of alcohol as it is this license is being granted per Minn. Stat. 340A.4041.
