2. Fourth Street Saloon Inc. agrees to hire off-duty police on Friday, Saturday, and Sunday nights. An established schedule will be made available to Business Licensing upon request.
3. Fourth Street Saloon Inc. agrees to establish and enforce a Code of Conduct for customers to include the prohibition of any gang related apparel and enforcement of patron behavior standards.
4. Fourth Street Saloon Inc. agrees to establish and enforce a " Do Not Admit List "
5. Fourth Street Saloon Inc. agrees to install and maintain Quiet Zone signage in the parking lot and exterior of the building.
6. Fourth Street Saloon Inc. agrees that the DJ will make an announcement at the end of the evening informing customers to leave the premises promptly in a quiet and respectful manner.
7. Fourth Street Saloon Inc. agrees to maintain video surveillance inside the premises and provide video surveillance upon request.
8. Fourth Street Saloon Inc. agrees to perform internal/external sweeps every half hour. A log book will be maintained and made available for review upon request.
