PREMISES BUSINESS/PLAN/OPERATIONS


The applicant is requesting to upgrade their level of entertainment from a Class D to a Class C-1 and add a 10 seat sidewalk café license. Also, Sisyphus Brewing will permanently expand the interior of their premises by adding 1300 square foot to serve tap beers. Sisyphus Brewing plans to host bands of five or fewer people as well as comedy nights. These events will be held weekly on Thursday, Friday, and Saturdays. Sisyphus Brewing is located in an industrial area with no residences within the 600 feet notice area. There have been no complaints against this license. Employees will continue to provide security for the venue. There are no outdoor speakers.

PUBLIC HEARING SUMMARY

A public hearing will be held at the CD & RS committee on Tuesday, September 15, 2015 at 1:30p.m. On August 26, 2015, 13 notices have been sent to residents within 600 feet of the entrance to the Sisyphus. An electronic hearing notice was e-mailed to Council Member Lisa Goodman, to the Lowry Hill Neighborhood Association, South Hennepin Business Association, Bryn Mawr Neighborhood Business Association, and Loring Business Association.
