**Public Hearing Requirement:** A public hearing is required for this license application. 77 notices were mailed to residents and property owners within 300 feet of the premises, and emailed to Marcy Holmes Neighborhood Association, Dinkytown Business Association & Council Member Frey on August 27, 2015. The public hearing will be held on September 15, 2015, at the Community Development and Regulatory Services Committee meeting.

**Background:** Licensed as a restaurant at this location and there have been no neighborhood complaints concerning the operation of the business.

**Findings as Required by the Minneapolis Licensing Code:** The Licenses and Consumer Services Division have analyzed the application and conclude that the application has answered the following:

**A security plan that describes the security features, including personnel and equipment, that the applicant will employ and how they will be utilized.**

Starbucks has had a security review with 2nd Police Precinct Inspector Kathy Waite. She concurs that the security submitted is adequate for the Starbucks location at 425 SE 14<sup>th</sup> Avenue. Starbucks has a written policy on security issues. They train all employees on how security issues are to be handled.

**Description of how the applicant will maintain the orderly appearance and operation of the premises with respect to litter and noise.**

Starbucks does not offer any entertainment or any background music at this location. They do not have a parking lot and most of their business is walk up traffic. Starbucks has a company policy that cleanup is done upon opening and closing each day and hourly clean sweeps of property.

**Such other reasonable and pertinent information as the city council may require.**

**Proximity to permitted or conditional residential uses.**

Starbucks at 425 SE 14<sup>th</sup> Avenue is located in a multi-use building; the entrance is at the sidewalk level and the one block area surrounding them is residential/commercial mix.

**Nature of the business and its impacts of noise, light and traffic.**

Starbucks business is mainly walk up patrons. The SE 14<sup>th</sup> Ave and 5<sup>th</sup> Street SE intersection has a high traffic volume that is not impacted by the Starbucks patron. They do not have on-site parking. They have no lighted signage.

**Conformance with applicable zoning regulations, including but not limited to use, yards, gross floor area and specific development standards.**

The business is categorized as a food restaurant which is a permitted use in the C1 district.

**History of complaints related to the use.**

Starbucks has no complaints.
