Subject: Land Sale Public Hearing
Vacant Housing Recycling Program

Recommendation: Approve the sale of 3712 28th Avenue South to Accent Homes, Inc. for \$26,100, subject to the following conditions; 1) land sale closing must occur on or before 90 days from the date this Resolution is approved by the City and 2) payment of holding costs of \$300.00 per month if the land sale closing does not occur on or before the closing deadline. The sale conditions may be waived or amended with approval of the Community Planning & Economic Development (CPED) Director.

Previous Directives: The City acquired 3712 28th Avenue South on March 8, 2013.

PROPOSED DEVELOPMENT:

The developer proposes to build a 1,919 square foot four-bedroom, two-bathroom single family house with a full basement and a double car detached garage. This home will be offered for owner-occupancy.

The lot size is 46' x 126' = approximately 5,796 total square feet.

LAND DISPOSITION POLICY:

This property is a buildable lot as defined by City policy and is being sold for development.

FINANCING*:

Developer's working capital.

*Subject to application and underwriting requirements.

OFFERING PROCEDURE:

Public Advertisement. The sales price of this property does reflect the full re-use value.

COMMENTS:

Four proposals were submitted for this parcel—Reuben Moore, Accent Homes, Inc., Herbert and Mary Heidkamp and Obsiyu Beyan. The Heidkamps withdrew their proposal as they purchased a privately-owned parcel where they could start development of their future homestead sooner. The proposal submitted by Obsiyu Beyan did not meet the program criteria.

The neighborhood recommended both the Reuben Moore and Accent Homes, Inc. proposal. Staff is recommending the Accent Homes, Inc. proposal because Reuben Moore is being recommended for a different parcel—3708 28th Avenue South, where he plans to build and owner-occupy the unit.

Authorizing sale of land Vacant Housing Recycling Program Disposition Parcel TF-802.

Whereas, the City of Minneapolis, hereinafter known as the City, has received an offer to purchase and develop Disposition Parcel TF-802, in the Standish neighborhood, from Accent Homes, Inc., hereinafter known as the Redeveloper, the Parcel TF-802, being the following described land situated in the City of Minneapolis, County of Hennepin, State of Minnesota to wit:

LEGAL DESCRIPTION

TF-802; 3712 28th Avenue South

Lot 4, Block 8, Hull's Addition to Minneapolis, except the North 3 feet thereof

Whereas, the Redeveloper has offered to pay the sum of \$26,100, for Parcel TF-802 to the City for the land, and the Redeveloper's proposal is in accordance with the applicable Redevelopment Plan and/or Program; and

Whereas, the Redeveloper has submitted to the City a statement of financial responsibility and qualifications; and

Whereas, the City has had the re-use value reviewed by an appraisal expert, stating that the re-use value opinion is consistent with the accepted methods in aiding the City in determining a re-use value for the Parcel; and

Whereas, pursuant to due notice thereof published in *Finance and Commerce* on July 31, 2015, a public hearing on the proposed sale was duly held on August 11, 2015, at the regularly scheduled Community Development & Regulatory Services Committee meeting of the City Council, at the Minneapolis City Hall, 350 South 5th Street, Room 317, at 1:30 p.m., in the City of Minneapolis, County of Hennepin, State of Minnesota;

Now, Therefore, Be It Resolved by The City Council of The City of Minneapolis:

That the re-use value for uses in accordance with the Vacant Housing Recycling Program plan, as amended, is hereby determined to be the sum of \$26,100 for Parcel TF-802.

Be It Further Resolved that the acceptance of the offer and proposal is hereby determined to be in the best interests of the City and its people and that the transaction furthers the City's general plan of economic development in accordance with the City's approved disposition policy and it is further determined that the Redeveloper possesses the qualifications and financial resources necessary to acquire and develop the parcel in accordance with the Redevelopment Plan and/or Program.

Be It Further Resolved that the proposal be and the same is hereby accepted, subject to the execution of a contract for the sale of land and further subject to the following conditions; 1) land sale closing must occur on or before 90 days from the date this Resolution is approved by the City and 2) payment of holding costs of \$300.00 per month if the land sale closing does not occur on or before the closing deadline.

Be It Further Resolved that the sale conditions described above may be waived or amended with the approval of the CPED Director.


Be It Further Resolved that upon publication of this Resolution, the Finance Officer or other appropriate official of the City be and the same is hereby authorized to execute and deliver the contract to the Redeveloper; provided, however, that this Resolution does not

constitute such a contract and no such contract shall be created until executed by the Finance Officer or other appropriate official of the City.

Be It Further Resolved that the Finance Officer or other appropriate official of the City is hereby authorized to execute and deliver a conveyance of the land to the Redeveloper in accordance with the provisions of the executed contract and upon payment to the City for the purchase price thereof; provided, however, that this Resolution does not constitute such a conveyance and no such conveyance shall be created until executed and delivered by the Finance Officer or other appropriate City official of the City
