History of Location

Clifton Holliday has operated several Sidewalk Food Carts in Downtown Minneapolis since April 2013. The carts were located on Nicollet Mall previously but due to the reconstruction all Sidewalk Food Carts were requested to find new locations. This is one of the new locations for Top Dog's cart. They operated at this location for 35 days (June 5 – July 10, 2015) using a Temporary Extended Hours permit.

Police Review

Minneapolis Police Licenses and 1st Precinct reviewed the financial, criminal and security plans for Top Dog. They have determined that Top Dog meets the minimum ordinance requirements for an Extended Hours license. However, the Police have safety, security, and/or operational concerns for the hours requested. MPD does not recommend hours extend past 1:30am at this time.

Premises

The premises are located on Hennepin Ave just north of 5th St S. The sidewalk food cart will be located in the front of the building facing Hennepin Ave. The cart will be 58' north of the curb at 5th St, 4' south of the hydrant.

Business Plan/Operations

Top Dog is a Sidewalk Food Cart that sells quick serve hot dogs and prepackaged chips and sodas.

PUBLIC HEARING

A public hearing will be held on Tuesday, August 11, 2015 at the CD&RS Committee. 68 notices were sent on July 21, 2015 to residents and property owners within 300 feet of Top Dogs proposed location.


