Chapter 525, Administration and Enforcement, Article II, Duties of Decision Making Bodies and Officials, Section 525.110, Board of Adjustment, article (d) *Membership*:



The board shall consist of nine (9) members who shall be appointed by the city council from an advisory list submitted to it by the city planning commission. All appointments shall be made after solicitation of resident nominees from organizations broadly and geographically representative of community interests. Members shall serve for a term of three (3) years, and shall be appointed as the terms of the present members of the existing board of adjustment expire. All members shall continue in office until their successors are appointed. Any member of the board may be removed therefrom for cause by the city council.
